It is important to remember that only REALTOR® members are given the opportunity to nominate the Affiliates for consideration. This is one of the ways REALTORS® thank our Affiliates for donating their time and talents to make this Board successful. The announcement is made at the Installation & REALTOR®/AFFILIATE of the Year Banquet held in January. Thank you for taking the time to select the nominees to be considered.

## REALTOR® OF THE YEAR PROGRAM Criteria

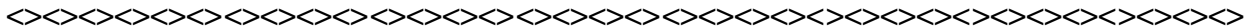
REALTOR® of the Year Program: Is designed so members can nominate a REALTOR® member who has contributed most to the advancement of his/her profession and the community at large during the current year.

### I. PURPOSE

To recognize and award a REALTOR® member for effort expended in the interest of their fellow REALTORS®, their community, and the real estate profession and who exemplifies the highest level of professional conduct in serving the real estate needs of the public.

### II. Criteria for selection of REALTOR® of the Year

- A. REALTOR® Professionalism
- B. Board activity (This can be filled out by staff but is a critical component)
- C. Community Service



## AFFILIATE OF THE YEAR PROGRAM Criteria

This program is designed to allow REALTOR® members the opportunity to nominate an Affiliate who has gone above and beyond to bring professionalism and service to the industry. In order for the Affiliate to be considered they must be active and instrumental to the advancement of the Board.
